



Safety First Healthcare developed its business based on in-depth research and established contacts in Asia. When we founded Safety First we decided to investigate Asia countries which could meet four important, basic requirements:

- 1) High government standards and strict regulations for personal protective equipment
- 2) Country free of political entanglements and controversy affecting the supply chain
- 3) Country free of trade wars
- 4) Skilled and reasonably priced labor pool

Based on this criteria, Safety First quickly found a large mask factory in Vietnam, called Nutica, which has Vinacontrol, CE, FDA and ISO certifications, but was primarily selling to Vietnam clients. Safety First is the majority shareholder of Nutica and since taking ownership, we have gathered 22 other small factories in Vietnam under the Nutica umbrella. Together we are able to produce 35 million masks per week and are significantly increasing our production capacity. We have been able to expand the mask product offerings to include a variety of masks specific to the needs of our medical professional clients.

Additionally, Safety First offers masks for the general public and are in the process of expanding the offerings. In this new world environment having comfortable, safe masks suited for all ages has become a critical consideration for most families.

We also have a gown, cap and bootie factory, called Delatech, under the Safety First group. Delatech produces various types of medical gowns as well as full protective and isolation suits with hood and booties. Delatech has Vinacontrol, CE, FDA and ISO certifications.






